Froot Loops® Eating Contest Registration Form

17 and Under (3:00 pm) — Ages 18+ (Immediately following)— Teams of 2 (after Adults)
Registration will be limited to 5 participants in each category. First come, first eligible to enter.
Pre-Registration is REQUIRED!!!!

Awards will be given to 1st place in each category only. There are no awards for 2nd or 3rd place in any age division.

CONTEST RULES

- No hands can be used during the “race” (does not apply to stuffing competition)
- No one can assist you, for the duration of the competition
(Exception– Couples Competition: allows for partners help only)
- The first person to finish his/her Froot Loops® Feast AND STANDS UP will be declared the winner by the contest judge
- In the event of a tie, whichever contestant that displays the biggest “Froot Loops® Eatin Smile” will be deemed winner by the contest judge
- ANY visible signs of sickness or illness is means for disqualification from the contest and will be asked to step aside
- EACH contestant/participant must complete the REQUIRED documentation PRIOR to the Froot Loops® Eating Contest starting at 3pm on Aug. 13, 2022.
- WAIVERS from each contestant must be turned into Party in the Park Staff BEFORE competition begins
- Participants under the age of 18, must have a parent/guardian present at the Froot Loops® Eating Contest in order to compete. This said parent or guardian must also be the cosigner on the WAIVER FORM submitted to Party in the Park Staff

LIABILITY WAIVER

Contestant acknowledges that there are risks of personal injury, illness and possible loss of life, and risks of damage to or loss of personal property, which may result from participating in this contest. Contestant voluntarily enters the Party In the Park Froot Loops® Eating Contest and assumes all of these risks.
