

ORDINANCE NO. 4462

AN ORDINANCE ADOPTING AND INCORPORATING BY REFERENCE THE “UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES,” 41st EDITION, 2025, AMENDING SECTION 9.04.010.

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GREAT BEND,
KANSAS:**

SECTION 1. That Section 9.04.010 of the Great Bend Code is hereby amended to read as follows:

“Sec. 9.04.010 Uniform Public Offense Code adopted; local amendments.

(a) Pursuant to K.S.A. 12-3009, the “Uniform Public Offense Code for Kansas Cities”, 41st Edition, 2025, prepared and published by the League of Kansas Municipalities, is incorporated by reference, as though fully set forth herein, subject to the local amendments set forth in this section. The corresponding section numbers used in the adopted Uniform Public Offense Code shall be used in citing violations of this chapter. One copy of the adopted Uniform Public Offense Code shall be marked “official copy as incorporated by Ordinance No. 4462” and kept on file in the office of the City Clerk for inspection by the public at all reasonable business hours.

(b) The adopted Uniform Public Offense Code is amended follows:

(1) Section 6.7(a)(1) of the adopted Uniform Public Offense Code is hereby amended to read as follows:

“(a) Criminal trespass is entering, or remaining upon or in any:

(1) Land, non-navigable body of water, structure, vehicle, vehicle, aircraft or watercraft by a person who knows such person is not authorized or privileged to do so and:

(A) Such person enters or remains therein in defiance of an order not to enter or to leave such premises or property personally communicated to such person by the owner thereof or other authorized person;

(B) Such premises or property are posted in a manner reasonably likely to come to the attention of intruders, or is locked or fenced or otherwise secured against passage or entry;

(C) Such person enters or remains therein in defiance of a restraining order issued by a court of competent jurisdiction and the restraining order has been personally served upon the person so restrained; or

(D) Such person is in a city park at hours or times that the park is not open as defined by Section 12.28.010 of the Great Bend Code.


SECTION 2. That the existing Sections 9.04.010 of the Great Bend Code is hereby repealed.


SECTION 3. That the City Clerk is instructed to cause this ordinance to be published once in the official City newspaper, as soon as practicable.

SECTION 4. This ordinance shall take effect on October 10, 2025.
