

ORDINANCE NO. 4461

AN ORDINANCE ADOPTING AND INCORPORATING BY REFERENCE THE "STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES," 52nd EDITION, 2025, AMENDING SECTION 10.04.010 OF THE GREAT BEND CODE

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GREAT BEND,
KANSAS:**

SECTION 1. That Section 10.04.010 of the Great Bend Code is hereby amended to read as follows:

"Sec. 10.04.010 Standard Traffic Ordinance adopted; local amendments.

(a) Pursuant to K.S.A. 12-3009, the "Standard Traffic Ordinance for Kansas Cities", 52nd Edition, 2025, prepared and published by the League of Kansas Municipalities, is incorporated by reference, as though fully set forth herein, subject to the local amendments set forth in this section. The corresponding section numbers used in the adopted Standard Traffic Ordinance shall be used in citing violations of this chapter. One copy of the adopted Standard Traffic Ordinance shall be marked "official copy as incorporated by Ordinance No. 4461" and kept on file in the office of the City Clerk for inspection by the public at all reasonable business hours.

(b) The adopted Standard Traffic Ordinance is amended follows:

(1) Subsection (c) of Section 84 of the adopted Standard Traffic Ordinance is amended to read as follows:

"(c) Any police officer is hereby authorized to remove or cause to be removed to the nearest garage or other place of safety, any vehicle found upon a highway when:

- (1) Report has been made that such vehicle has been stolen or taken without the consent of its owner;
- (2) The person or persons in charge of such vehicle are unable to provide for its custody or removal;
- (3) The person driving or in control of such vehicle is arrested for an alleged offense for which the officer is required by law to take the person arrested before the municipal judge without unnecessary delay; or
- (4) Such vehicle is a commercial vehicle that is illegally parked."

(2) Section 88 of the adopted Standard Traffic Ordinance is amended to read as follows:

"Sec 88. Parking for certain Purposes Prohibited. No person shall park a vehicle upon a any street for the purpose of:

- (a) Displaying such vehicle for sale;
- (b) Advertising; or

(c) Washing, greasing or repairing of such vehicle except for repairs necessitated by an emergency.”

(3) Subsection (a) of Section 117 of the adopted Standard Traffic Ordinance is amended to read as follows:

“Sec. 117. Limitations on Backing.

(a) The driver of a vehicle shall not back the same around a corner at an intersection, into an intersection, or at any other location on a street or highway within the city unless such movement can be made with safety and without interfering with traffic.”

SECTION 2. The existing Section 10.040.010 of the Great Bend Code is hereby repealed.

SECTION 3. The City Clerk is instructed to cause this ordinance to be published once in the official City newspaper, as soon as practicable.

SECTION 4. This ordinance shall take effect on October 10, 2025.
