# FIRE PIT SAFETY GUIDELINES

FOR CLARITY, A **"FIRE PIT"** INCLUDES BELOW GROUND PITS, FREE STANDING FIREPLACES, CHIMINEAS, AND ALL PORTABLE DEVICES INTENDED TO CONTAIN AND CONTROL OUTDOOR FIRES.



- All below ground fire pits shall be at least four inches in depth and shall be surrounded on the outside, above ground, by a noncombustible material such as steel, brick, or masonry.



- The flames shall not exceed 2 feet in height.

- The fire pit shall be no more than 3 feet in diameter.
- The fire pit should be on a noncombustible surface.
- The fire pit should be in good working order and well maintained.



- The fire pit should be provided with a screen with openings no greater than one inch, and the fire should be contained within the screen.
- The fire pit shall be a minimum of 10 feet away from all structures.
- Conditions within 10 feet of the fire pit which could cause a fire to spread shall be eliminated prior to ignition, (i.e. log pile, overhanging trees, dry vegetation, etc.).



- A portable fire extinguisher or other fire-extinguishing equipment, such as water hose or water barrel, shall be immediately available.

- The wind speed shall be less than 15 mph.



- No burning allowed when Barton County Burn Ban is in effect.
- Open fires shall be constantly attended by a competent person until such fire is extinguished.
- Only natural firewood/commercial logs may be burned. It is best to use a hard wood that does not create a lot of embers.
- Open burning that is offensive or objectionable because of smoke or odor emissions, or when atmospheric conditions or local circumstances make such fires hazardous shall be prohibited.
- The fire pit shall not be used to dispose of trash, rubbish, leaves, or combustible waste material.
